**TAXES ARE DUE JANUARY 31, 2021**

Payment received or postmarked after January 31, 2021 will be delinquent and subject to interest and penalty charge.

Second half or delinquent payments are due to the Waukesha County Treasurer after January 31, 2021.

**INFORMATION REGARDING YOUR TAXES:**

The Treasurer's duty is to collect all taxes as shown on the Tax Roll. The Treasurer cannot change, reduce, or cancel any tax.

**-NOTICE TO DOG OWNERS-**

All dogs over 5 months old must have a license. Altered Males or Females \$8.00; Males \$12.00; Females \$12.00. Dog license ordinance will be enforced. See reverse side for Dog License Application.
