

## ORDINANCE NO. 2022-03

AN ORDINANCE TO REPEAL AND RECREATE ORDINANCE 16-02, AN  
ORDINANCE TO REGULATE CULVERTS

WHEREAS, on September 21, 2016 the Town Board for the Town of Eagle adopted Ordinance 16-02 to Repeal and Recreate Ordinance 02-01; and

WHEREAS, the Town Board finds that the revisions to Ordinance 16-02 as set forth in this Ordinance will promote the public health, safety and welfare;

NOW, THEREFORE, the Town Board of the Town of Eagle do hereby ordain as follows:

SECTION 1. Ordinance No. 16-03 is hereby repealed and recreated to read as follows:

## CULVERT REGULATIONS

1. Permit Required. From and after the effective date of this ordinance no person shall install or replace a culvert accessing any road, street, or highway in the Town of Eagle without obtaining a written permit from the Town Engineer of Eagle or designee appointed by motion by the Town of Eagle Board.
2. Size. The length and size of all culverts shall be established by the Town Engineer. Culverts shall be a minimum of 22 feet in length and a maximum of 28 feet in length
3. Construction. Culverts shall be constructed of corrugated metal piping, with flared ends and must conform with all other standards as set forth by the State of Wisconsin Department of Transportation.
4. Fee. A nonrefundable fee in an amount established by the Town Board by motion from time to time shall accompany the application for a permit.
5. Enforcement and Penalty. This ordinance may be enforced and citations issued by the Town Building Inspector or the Town Attorney. Upon conviction, the violator shall forfeit a minimum of \$50 up to a maximum of \$500 per day plus costs and assessments.

Section 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

Section 3. EFFECTIVE DATE. This ordinance shall be effective from and after its posting or publication as required by law.
